APPROVAL OF MINUTES: The Board reviewed the June 2022 minutes. Rose motioned to approve the minutes as amended, Marci seconded. The Board unanimously approved the June 2022 minutes as amended.

- The Board reviewed the proposal submitted by Solitude Lake Management to rebuild or replace the pump at the pond for \$2,118.00.
  - o Marci motioned to approve the proposal; Lennin seconded. The Board unanimously approved the proposal.
- The Board reviewed the proposal submitted by Chapel Valley to plant grass around the overflow grate at the pond for \$1,042.42.
  - o Marci motioned to approve the proposal; Rose seconded. The Board unanimously approved the proposal.
- The Board reviewed the proposal submitted by Down to Earth Landscaping for drainage repair for \$19,867.29
  - During discussion, the Board agreed that the landscaping and trail portion of \$480 and \$1590 needs to be removed from the contract as it is not needed for this project.
  - Marci motioned to approve the proposal, contingent upon Joe Arizzi from Kimley Horn reviewing and approving the proposal, Rose seconded. The Board unanimously approved the Down to Earth proposal, contingent upon the Kimley Horn review.

ADJOURNMENT: Lennin moved to adjourn; Rose seconded. The Board unanimously approved to adjourn at 7:36pm.
