Mayor Responds to QHA Concerns

Due to the unsightliness and possible negative effect on real estate sales, an email concerning the vacant town homes located at Duke Street and Yale was sent to Alexandria Mayor William Euille. It specifically addressed the extent of the work that still needed to be done on the units, asked why it was taking so long to get the job done, and requested a schedule of when the units should be repaired.

A response to the email was received from William M. Dearman, Chief Executive Officer of the Alexandria Redevelopment and Housing Authority (ARHA). His response included a copy of a memorandum submitted by ARHA to the Mayor dated August 23, 2006.

The memorandum essentially defined the structurally related problems of the ARHA homes. Upon visual inspection (Phase I) by a structural engineer from Meyer Consulting Engineers (MCE) Corporation, the report noted "bowed and or undulating front brick façade; cracks in the front brick façade; cracked front foundation walls and difficulty opening / closing front doors and windows." Phase I resulted in the replacement of the retaining wall with a reinforced concrete wall designed to sustain soil loadings.

Unfortunately, during the course of Phase I construction, a gas line was hit and a stop work order was issued by the City. Residents were evacuated for their safety and the work was not completed until the end of February 2006. By that time, the units had suffered significant distress due to the structural issues and it was determined that ARHA would need to complete a revision to its Capital Fund budget in order to secure funding to do substantial rehabilitation to the units in order to bring them back on line. That has been accomplished.

Long story short, hearings were conducted with the Resident Advisory Board, budgetary approvals were received by the ARHA Board of Commissioners and HUD, and a Request for Qualifications was published to complete the construction for the "substantial" rehab required to put the units back in livable condition. Once a contractor has been identified, a six month construction duration is anticipated, meaning the units will be back on line later this year—"unless unforeseen conditions are encountered".

You too can have a voice in community concerns or activities – to do so, go to the City of Alexandria webpage, click on Citizen Government, then Mayor and Council, then email Mayor and you are ready to compose. You are guaranteed a response (but you just might not like it.)

Trash Disposal

Residents of single-family detached homes and townhomes are reminded that trash containers may not be placed outside earlier than 5:00 p.m. on the evening before collection and must be returned to storage not later than 7:00 p.m. the day of collection. Please put your trash can out of view on non-pick up days.

The regular trash collection day is Tuesday. During a week when Monday or Tuesday is a holiday, you may call the City's Office of Solid Waste at (703)751-5130 or check the City of Alexandria website at <http://ci.alexandria.va.us>.

TMP Program

Ever wonder what the TMP Program is? As a condition for approval for a multi-family development project, it was a requirement to participate in a city wide program that promoted mass transit. (MOST new multi-family housing developments are required to do so!) Part of our monthly assessment fee funds this program. As a bonafide resident of Quaker Hill, you are eligible to purchase certain mass transit media at a reduced price. The type of media, the pricing and how to obtain it are always published in this newsletter. It is an excellent benefit to living in this beautiful community!

Alexandria Spring Clean Up Day

Spring Clean Up Day for Quaker Hill!!!

How to participate:

This is a free service made available to residents who receive City of Alexandria refuse collection. Residents who receive refuse collection from private contractors do not receive spring cleanup collection.

1. Place your materials at the CURB (no alley pick ups!) before 7 a.m. on your assigned collection day (May 5th for Quaker Hill).
2. Materials should be placed in containers and all brush and lumber must be tied in bundles no more than four feet long and not more than 75 pounds.

Examples of acceptable materials: Appliances, steel pipe, furniture, mattresses, brush and tires off the rim

Examples of UNACCEPTABLE materials: Concrete, hazardous waste, unbundled lumber or brush, building materials, loose yard waste



The City webpage also lists Reuse and Donation Options with links to multiple sites and organizations which can use building materials, clothing, furniture, household goods and many other items.

Rockscape

As tempting as it may be to pick up some of the rocks around the pond and toss them in (we know it's hard to resist), please don't! We have two major issues:

- 1) The rocks have been purchased and placed to prevent erosion and to slow water drainage into the pond. They are paid for by the community and have to be replaced. (You would be amazed at what rocks cost!)
- 2) We will be paying to have the pond dredged of rocks, dirt, debris and other matter in order to keep it healthy, clean and at the proper capacity. So not only do we pay to put the rocks around the pond, now we're paying to take them out!

So while skipping rocks and making big splashes may be lots of fun, please avoid the temptation!

Pond Dredging and Clean Up

A formal engineering study has been done on the pond, and between the study and the problems we have been experiencing with the aeration pumps, the Board is moving forward with bids to complete the dredging. They are also considering the installation of an underwater "catch basin" near the intake areas which tend to trap the incoming debris. This makes it easier for future dredging and tends to trap onrushing debris on the bottom of the pond closer to the intake areas. Current pond designs generally incorporate this feature. Bids, permits and possible financial relief from the City are also being sought.

Vehicle Repair and Oil Changes

Please be aware that the performance of major repairs to vehicles, including painting and drainage of automobile fluids, is not permitted anywhere in open view on residential lots or common areas within the boundary of the property (Policy Resolution Number 7, amended March 10, 1997).

NEW PARKING FINES EFFECTIVE FEBRUARY 1 IN CITY OF ALEXANDRIA

Revised Schedule Brings City's Fees in Line with Neighboring Jurisdictions Council Also Raises Charges for Disability Space Violations

New parking fines went into effect in the City of Alexandria on Thursday, February 1 under a revised parking ordinance enacted by the Alexandria City Council at its January 20 public hearing meeting.

The revised ordinance increases most fines for meter, parking, and tag violations by \$5. Citations issued for meter violations increased from \$20 to \$25, while fines for most parking and tag violations increased to \$40.

The City Council also increased by \$23 the prepaid processing charge for unauthorized parking in spaces reserved for persons with a disability, from \$28 to \$51, the maximum allowed. Along with the \$150 fine, total prepaid charges for parking in a disability-reserved space are \$201, effective February 1.

The Code of Virginia authorizes the City of Alexandria to regulate parking, stopping and standing of vehicles within its limits and to establish penalties for violations.

The City Council acted to increase fines in order to facilitate business activity for City merchants by promoting greater turn-over of on-street parking spaces. While fines are meant to discourage motorists from parking illegally, City staff reported that some motorists have been willing to pay the fines because of their relatively low cost. The City's parking fines generally have not increased since 1992 and are currently lower than fines charged by neighboring jurisdictions for comparable violations.

The City issued 82,090 parking citations and collected \$2.6 million in parking fines in FY 2006.


Tot Lot Rules

Spring will be here soon and our new tot lot will be welcoming our little ones! Please be aware of our tot lot rules for use. A quick summary:

1. Tot lot hours are 8 am to dusk. (Not after sunset! Lost privileges and trespassing risks apply!)
2. The tot lot is for residents and their guests, and the children should be under the age of ten (10). The equipment is not built for older children.
3. Children under the age of six (6) must be escorted by a person who is thirteen (13) years or older and guests must be escorted.
4. The Association assumes no responsibility for any accident or injury in connection with the use or for any loss or damage to personal property. Use of the tot lot is at your own risk. (A necessary precaution and rule)

General safety and conduct rules:

No smoking, no breakable objects, no intoxicants, no pets, and of course no profanity or boisterous behavior (this is a TOT lot!) Safety is of primary concern to the Association and its members and while it may seem unnecessary to state some of these rules, we do want to insure that the tot lot is safe, clean and used properly!
